How to Register Your Vulnerable Sector Check

Before you start you are going to need a copy of your Vulnerable Sector Check along with the OHF Screening Declaration Form. You will also need your HRC# which can be found after you have finished registering with the Hockey Federation. Steps to find this number are located further in the document. Below is an example of each of the forms required along with a link if you do not have them.
